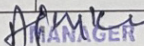

TERMS & CONDITIONS:

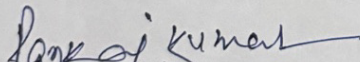
1. The School Management Committee has been constituted strictly as per the Affiliation Bye-Laws of Central Board of Secondary Education.

6. All decisions taken by the committee shall be recorded in the proceedings register and signed by members present.

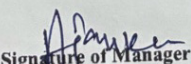

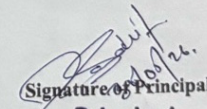
