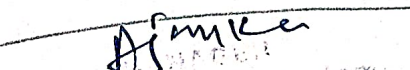
- v) Out of income of the Trust the Trustee shall defray the expanses for running the School also for procuring necessary infrastructural faculties for this purpose.

- viii) The Trustee shall have power on behalf of Trust to borrow money from banks. Financial institutions and individual to fulfill objectives of the Trustee.
- ix) The Trust fund may be augmented from income of the initial endowment and also by donation and other contribution from time to time. The Trustee shall be empowered to accept donation, contribution, grant or subscriptions in cash or in kind for the trust from any person(s) body of person and organization.
- x) Managing Trustee shall be required to nominate and among the Trustee of officiate for him and carry out his assignments during his absence or unavailability.
- xi) Trustee shall work man hooray capacity but shall be entitled to reimbursement of the all expenses actually incurred by them in connection with the work of the Trust or their duties relating thereto.

xii) Account of the trust shall be opened with a banks or banks which shall be operated singly by the Managing Trustee.

xiii) The minimum number of the Trustee shall not be less than three and maximum number not more than eleven. The Managing Trustee shall appoint a replacement Trustee only on temporary basis to fill the immediate Vacancy arising out of sudden death, resignation etc to maintain the number of required trustee. However appointment of a regular Trustee shall be done by majority vote of the Trustees, if not by consensus.

xiv) A minimum three number of Trustee shall be required to form Quorum of the meeting of the Trust.

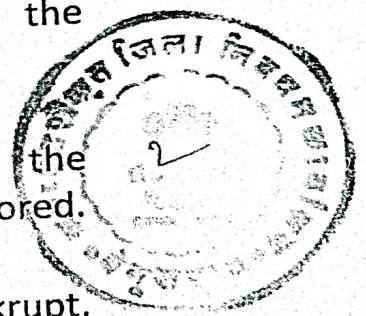

xxi) The accounting year of the trust shall be the financial year ending on 31st March every year.

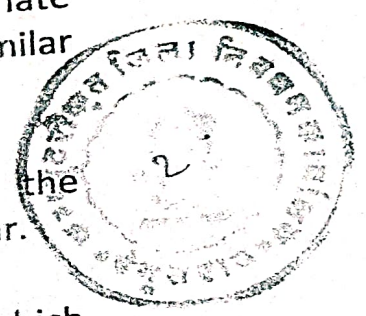
xxii) The Trustee shall maintain proper accounts which shall be audited by the chartered accountant appointed by the Board of Trustees.

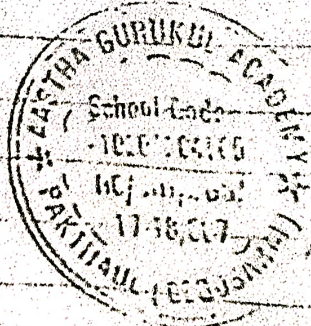
