11. That, the School will ensure that a sufficient number of qualified teachers, as per the provisions contained in the Affiliation Bye-laws, are available with the School before starting classes.

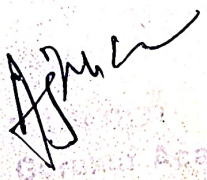

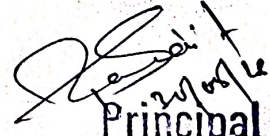
13. That, the School will not force any student or parent to buy books, stationery or uniform from any particular shop.

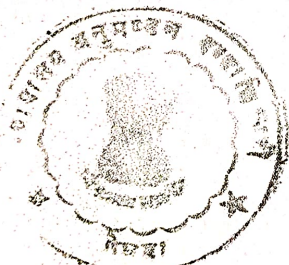
